## Organization and Rules

**SwissCham China** is the Chamber of Commerce for Switzerland officially registered in China with the Ministry of Civil Affairs under the Provisional Regulations for the Administration of Foreign Chambers of Commerce in China.<sup>3</sup> It is a federative organization. Local offices such as **SwissCham Beijing** are statutory known as **Regional Organizations**. Other Regional Organizations exist in Shanghai, Guangzhou, Shenzhen and in Chongqing (South West China). SwissCham Hong Kong<sup>4</sup> is legally independent but maintains close ties with SwissCham China with which it shares common projects.

SwissCham China has no operational activities and fulfils a representative and coordination role. Regional Organizations are represented by a **Board of Directors** which may delegate the Chamber's management to a General Manager in charge of the **Chamber's office**, as is the case in Beijing and Shanghai. SwissCham Beijing's organization chart is attached (Appendix "G").

SwissCham is governed by three sets of **Rules**: two on the national level and one on regional levels. National rules include the **National Articles of Association** and the **National Bylaws**. Regional rules include the Regional Bylaws, in Beijing, the **Beijing Bylaws**. In case of silence of the Regional Rules, the National Rules apply.<sup>5</sup> Finally, the decisions by which the Regional BOD implements the Rules are recorded in Minutes of the BOD Meetings. The National Articles, the National Bylaws and the Beijing Bylaws are attached (Appendices "D", "E", "F").

In order to sit, SwissCham Beijing's RAGA needs a **quorum of 50%** of SwissCham Beijing's members with voting rights. Members enjoy such rights upon approval of the BOD following the Rules. In any case, a member shall not enjoy voting rights if it has not paid his membership fees.<sup>6</sup>

## Regional Board of Directors of SwissCham Beijing

### Introduction

The Regional Board of Directors is in charge of supervising the management and of the representation of SwissCham Beijing.<sup>7</sup> It is composed of five Office Holders and six Directors of the Board and one Honorary Director.

The Office is composed of the President, two Vice-Presidents, the Secretary-General and the Treasurer.

A representative of the Embassy of Switzerland in China<sup>8</sup> serves as Honorary Director of the Board of SwissCham Beijing. The Embassy's representative, who usually is the Head of Economic, Financial and Commercial Section, sits on the BOD.

The Directors of the Board are elected at the RAGA<sup>9</sup> for one year.<sup>10</sup> The President is elected by the RAGA. The other functions are elected within the BOD.<sup>11</sup> Directors of the Board are expected to attend 2/3rd of scheduled Board Meetings. Their attendance has to be announced before the election.<sup>12</sup>

In compliance with the Rules, the BOD made this year repeated **open calls for candidacy to the BOD** to all the members, see Appendix "C".<sup>13</sup> Interested members are invited to send their resume to the Chamber's office. In order to allow time for copying your resume to the voting members, please submit your **candidacy until February 25, 2022 at the latest.**

At the RAGA, candidates will be requested to shortly introduce themselves and explain their motivation to the assembly before the proceeding of the elections.

### **The current Board of Directors**

The composition of the current BOD can be found in the **Organization Chart** (Appendix “G”).

As noted above, Directors of the Board are expected to attend 2/3rd of scheduled Board Meetings. The Directors may not stand for re-election if they did not attend 2/3rd of the Meetings.<sup>14</sup>

### **Candidature to the Board of Directors for the upcoming Chamber year**

The list of members or representatives of members, who would like to apply for the SwissCham Beijing’s Board of Directors, can be found in the **Organization Chart** (Appendix “G”).

## Elections

### Board of Directors

BOD members are elected by secret ballot by simple majority of the represented members at the RAGA.<sup>15</sup>

You have to elect **eleven Directors**, provided there are at least eleven candidates. Please use the **Voting Ballot No. 1** ([Appendix "N"](#)).

### President of SwissCham Beijing

Once you will have elected the Directors of the Board, you will have to elect among them the **President of SwissCham Beijing**. The same rules apply.

You will be invited to do so, and at the same time, you will elect the National Representatives. Please use the **Voting Ballot No. 2** ([Appendix "O"](#)).

### National Board Representatives

The Rules request that Regional Organizations such as SwissCham Beijing nominate, among the members of their Regional BOD, candidates for the National Board of Directors, among whom one **Regional President** and additional **National Representatives**.<sup>16</sup> These candidates will then have to be elected by the National Annual General Assembly (NAGA), which specific date and venue are announced in the attached [NAGA invitation](#).

Therefore in principle, you have to elect, among the SwissCham Beijing BOD members whom you just elected, **three National Representatives**.<sup>17</sup> The President of SwissCham Beijing may also be a National Representative and is usually the Regional President. The current National Representatives can be found in the **Organization Chart** ([Appendix "G"](#)).

National Representatives are elected for a maximum of three terms of two years and the Chairman two terms of two years.<sup>18</sup>

At the RAGA, or first-step level, the election shall follow the same rule as for the Regional BOD: National representatives are elected by secret ballot by simple majority of the represented members at the RAGA.<sup>19</sup> Please use the **Voting Ballot No. 2** attached (Appendix "O").

## **SWISS CHINESE CHAMBER OF COMMERCE CHINA ARTICLES OF ASSOCIATION**

("National Articles")

Last modified by resolution of the National General Assembly of March 27, 2015.

### **ARTICLE 1 NAME, SEAT, BUSINESS YEAR**

- (1) This organization shall be called in Chinese "Chinese Swiss Chamber of Commerce" or "Zhong Guo Rui Shi Shang Hui" and shall be called in English "Swiss Chinese Chamber of Commerce" or "SwissCham China" (the "National Chamber").
- (2) The National Chamber is established in accordance with the relevant laws and regulations of People's Republic of China ("China").
- (3) The National Chamber has its registered office at Room 611, Xinyuanli West 19, Chaoyang District, Beijing 100027, China.
- (4) The business year of the National Chamber is the calendar year, from January 1 to December 31.

### **ARTICLE 2 OBJECTIVES AND ACTIVITIES OF THE NATIONAL CHAMBER**

The National Chamber is a non-profit generating, non-governmental organization. The objectives and activities are:

- (a) To promote business relations between companies in Switzerland and China;
- (b) To cooperate with the authorities of both countries with the aim of furthering the common economic interests;
- (c) To represent, support and protect the interests of the members within the boundaries of the relevant laws and the National Articles;
- (d) To provide services to members and non-members engaged in trade, industry and commerce;
- (e) To promote communication and discussion with China's economic and cultural organizations;
- (f) To undertake cultural and recreational activities in the interest of and beneficial to the members.

## **ARTICLE 3 NATIONAL CHAMBER AND REGIONAL CHAMBERS**

### **SECTION A NATIONAL CHAMBER**

- (1) The National Chamber is the umbrella organization encompassing and consisting of the Regional Chambers in China.
- (2) All members of a Regional Chamber are implicitly members of the National Chamber.
- (3) The Board of Directors of the National Chamber (the “National Board”) is composed of members of the Board of Directors of each Regional Chamber.
- (4) The National Board is in charge of the overall guidance and supervision of the Regional Chambers. Amongst others, the National Board shall safeguard the interests of the Regional Chambers on a national level and coordinate and enhance the cooperation between the Regional Chambers.
- (5) The National Chamber may adopt bylaws in compliance with the National Articles (the “National Bylaws”).

### **SECTION B REGIONAL CHAMBERS**

- (1) Each Regional Chamber shall be independent in the organization of daily management and activities for its local members and, unless otherwise stipulated in the National Articles or the National Bylaws, in all membership issues.
- (2) Each Regional Chamber shall have the right to formulate, amend or abolish its bylaws, provided that such bylaws are in compliance with the National Articles and the National Bylaws.

### **SECTION C FINANCIAL CONTRIBUTIONS**

- (1) Each Regional Chamber shall be responsible for its own financials.
- (2) Each Regional Chamber shall make financial contributions to cover the costs and expenses incurred by the National Chamber.
- (3) The amount of contribution of each Regional Chamber shall be determined by the National Board based on the capacity of each Regional Chamber.

## **ARTICLE 4 REGIONAL AND NATIONAL MEMBERSHIP**

### **SECTION A CATEGORIES**

(1) Membership comprises of six (6) categories:

1. Corporate Members (with voting rights);
2. Individual Members (with voting rights);
3. National Associates (without voting rights);
4. Young Professionals (without voting rights);
5. NPO and Journalist Members (without voting rights);
6. National Honorary Members (without voting rights).

(1) Corporate Members with voting rights are commercial establishments such as representative offices, joint ventures, branches or subsidiaries, set up in China in accordance with Chinese law by Swiss nationals or companies, institutes or associations located in Switzerland.

(2) Individual Members with voting rights are Swiss nationals without restrictions or nationals of other countries who are employed by a commercial establishment as defined in Article 4 Section A (2) of the National Articles.

(3) National Associates without voting rights are commercial establishments, institutes or associations or individual persons that do not qualify as Corporate or Individual Member but who wish to be affiliated with the National Chamber to promote Sino-Swiss trade and economic relations and Sino-Swiss friendship.

(4) Young Professionals without voting rights are Swiss nationals or nationals of other countries under the age of 35 and self-employed or unemployed at the time of application of membership.

(5) NPO and Journalist Members without voting rights are (i) not for profit organizations without governmental affiliation set up in China in accordance with Chinese law by companies, institutes or associations located in Switzerland, and (ii) Swiss nationals engaged in the journalism or media sector.

(6) National Honorary Member without voting rights are personalities who have made great contribution to, or earned lasting merits for, the National Chamber or the trade relations between China and Switzerland.

## **SECTION B COMMENCEMENT OF MEMBERSHIP**

(1) The Board of Directors of each Regional Chamber (“Regional Board”) shall, except with respect to National Honorary Membership, decide on the admissibility of an applicant for membership or for a change in classification of membership.

(2) The National General Assembly shall decide on the admissibility of a person for National Honorary Membership upon recommendation by the National Board.

(3) Application of membership for a Regional Chamber shall be submitted to the respective Regional Board in written form.

(4) If the Regional Board approves an application for membership, the applicant shall become a member of such Regional Chamber only upon payment of membership fee as stipulated in Article 5 (3) of the National Articles.

## **SECTION C TRANSFER AND TERMINATION OF MEMBERSHIP**

(1) Membership in a Regional Chamber cannot be transferred to another member.

(2) Membership in a Regional Chamber terminates upon resignation, death or dissolution of that member.

(3) Non-payment of membership fee within three months upon receipt of the second reminder notice is considered a declaration of resignation by such member.

(4) Membership fees or other debts due to the Regional Chamber shall be paid within fourteen (14) days upon termination of membership.

## **SECTION D EXCLUSION OF MEMBERSHIP**

(1) The Regional Board may exclude a member by simple majority of the votes on important grounds. Important grounds are, in particular:

(a) Any behavior detrimental to the reputation or interest of the National Chamber or Regional Chamber.

(b) Any behavior of a member that aggrieves any other member of the Regional Chamber purposely in the light of adequate evidence.

(c) Any dishonorable conduct of a member.

(2) Any member of a Regional Chamber with voting right may file a motion to the Regional Board requesting to exclude a member on important grounds.

(3) Exclusion does not entitle such former member to any reimbursement of membership fee.

## **ARTICLE 5 RIGHTS AND OBLIGATIONS OF MEMBERS OF THE NATIONAL CHAMBER**

(1) Each member has the right to participate in the General Meetings of the National Chamber (the “National General Assembly”).

(2) Each member with voting rights has one vote in the National General Assembly. Corporate members shall vote through representatives. Members shall only have voting rights if their membership fees are paid for the past year(s) and for the current year in full.

(3) Each member shall pay membership fees to the respective Regional Chamber. The amount of the yearly membership fee shall be approved by the National General Assembly and notified to the members. National Honorary Members are not required to pay membership fees.

## **ARTICLE 6 MEETING OF THE NATIONAL CHAMBER (“NATIONAL GENERAL ASSEMBLY”)**

### **SECTION A ORDINARY AND EXTRAORDINARY NATIONAL GENERAL ASSEMBLIES**

(1) The National General Assembly is the supreme body of the National Chamber. There are Ordinary and Extraordinary National General Assemblies.

(2) An Ordinary National General Assembly shall be held annually in the first quarter of the business year.

(3) An Extraordinary National General Assembly shall be convened:

(a) If the National Board so decides; or

(b) If at least ten percent (10%) of all members with voting rights submit a written request to the National Board stating the reasons to convene it.

### **SECTION B POWERS OF THE NATIONAL GENERAL ASSEMBLY**

The National General Assembly shall, in particular:

(a) Approve the reports by the Chairman of the National Board, the President of each Regional Board, the Treasurer and the Auditor.

(b) Elect members of the National Board, the Treasurer and the Auditor;

(d) Approve the amount of the annual membership fees of a Regional Chamber;

- (e) Pass resolutions concerning the matters reserved to the National General Assembly by the National Articles;
- (f) Decide upon National Honorary Membership admission, rejection or termination;
- (g) Determine and amend the National Articles and the National Bylaws;
- (h) Approve the bylaws of a Regional Chamber;
- (i) Discharge the members of the National Board.

### **SECTION C PROCEDURES OF THE NATIONAL GENERAL ASSEMBLY**

- (1) Written notice shall be given to all members at least twenty (20) days prior to the date of an Ordinary National General Assembly and at least ten (10) days prior to the date of an Extraordinary National General Assembly.
- (2) The Chairman or Vice Chairman of the National Board shall act as Chairman of the National General Assembly. The Chairman of the National General Assembly has the casting vote.
- (3) The National General Assembly shall proceed in accordance with the pre-determined agenda. Any member of the National Chamber may submit a written request to the National Board for additional item to the agenda provided such request is made at least forty-eight (48) hours prior to the date of the National General Assembly.
- (4) The quorum shall be constituted if (i) at least twenty percent (20%) of all members with voting rights are present in person or by proxy, and (ii) at least ten percent (10%) of members with voting rights from each Regional Chamber are present in person or by proxy. Decisions are made by a simple majority unless the National Articles or National Bylaws provide otherwise.
- (5) The National General Assembly may hold secret voting.
- (6) Any member may vote through proxy, provided a written authorization letter is presented.
- (7) Minutes shall be recorded for all National General Assembly meetings and shall be placed on file at the registered address of the National Chamber for members' consultation.

## **ARTICLE 7 BOARD OF DIRECTORS OF THE NATIONAL CHAMBER (“NATIONAL BOARD”)**

### **SECTION A DUTIES OF THE NATIONAL BOARD**

The National Board shall represent, oversee and make policy decisions with respect to the activities of the National Chamber. The duties of the National Board are, in particular:

- (a) To represent, promote and protect the interests of the National Chamber and its members;
- (b) To lay down general guidelines for the management of the National Chamber;
- (c) To report to the National General Assembly;
- (d) To review the amount of membership fees proposed by a Regional Board and submit them to the National General Assembly for approval;
- (e) To establish committees or an Advisory Board and delegate duties or powers, if needed;
- (f) To fulfil all tasks of the National Chamber that do not belong to the lawful or statutory rights or obligations of the National General Assembly or the President of each Regional Board.
- (g) To review the budget proposed by the Treasurer or President of Regional Chamber and submit to the National General Assembly for approval.
- (h) To appoint and dismiss executive officers and staff of the National Board.

### **SECTION B COMPOSITION OF THE NATIONAL BOARD**

- (1) The National Board shall consist of at least six (6) members.
- (2) Each Regional Chamber shall be represented in the National Board by at least one (1) member.
- (3) Members of the National Board shall be elected by the National General Assembly for a term of two (2) years. Re-election is possible for maximum three (3) consecutive terms, i.e. totally six (6) consecutive years.
- (4) The National Board constitutes itself. The Chairman of the National Board shall be confirmed by the National General Assembly upon proposal by the National Board. The term of office of the Chairman of the National Board shall be two (2) years. Re-elections possible for maximum two (2) consecutive terms, i.e. totally four (4) consecutive years.

(5) If a member of the National Board leaves office before the end of his term of office, the respective Regional Chamber shall appoint a new member who shall hold office until the term of that National Board member ends.

### **SECTION C OFFICE HOLDERS WITHIN THE NATIONAL BOARD**

(1) The office holders amongst the members of the National Board shall consist of:

(a) A Chairman;

(b) Vice Chairmen, the number of which to be decided by the National Board;

(c) A Treasurer;

(d) Contingent further office holders.

(2) The duties of the Chairman of the National Board are, in particular:

(a) To convene and take charge of meetings of the National Board;

(b) To represent the National Chamber.

(3) The Vice Chairman or Vice Chairmen of the Board assist(s) the Chairman in fulfilling the duties. In the absence of the Chairman, the/one Vice Chairman shall act as the Spokesman of the National Board.

(4) The Treasurer shall, under the supervision of the National Board, take charge in:

(a) Managing properties and keeping the accounts of the National Chamber;

(b) Submitting to the National General Assembly financial reports.

(5) Compensation for duties performed by members of the National Board shall be decided by the National General Assembly.

### **SECTION D MEETING OF THE NATIONAL BOARD**

(1) The National Board shall convene at regular intervals of at least four (4) times per calendar year either in a physical meeting or by phone to discuss ongoing matters of concern to the National Chamber. A physical meeting shall be held at least once per calendar year.

(2) A meeting of the National Board shall also be convened by the Chairman upon a written request by at least one third ( $\frac{1}{3}$ ) of all the members of the National Board. The Chairman must convene the meeting of the National Board within fifteen (15) days upon receipt of such written request.



(3) The quorum shall be constituted if the majority of the members of the National Board is present in person or by proxy. If a quorum fails to be established, the meeting of the National Board shall be convened within the next fifteen (15) days.

(4) Decisions may be made by a simple majority unless the National Articles or National Bylaws provide otherwise. Each member of the National Board has one vote in the meeting. The Chairman has a casting vote.

(5) The members of the National Board may be represented by proxy, the proxy holder being one of the other members of the National Board.

(6) A Secretary on a non-permanent basis shall be appointed by the Chairman or his representative for each National Board meeting.

## **SECTION E REMOVAL OF A NATIONAL BOARD MEMBER**

In case of negligence of duty, violation of Chinese laws or regulations or any other behavior detrimental to the National Chamber and the Swiss Business Community in China, any National Board member may be removed from office by the National Board by a vote of at least three-quarters ( $\frac{3}{4}$ ) of all members of the National Board.

## **ARTICLE 8 MANAGEMENT**

(1) The Legal Representative shall be appointed by the National Board for a term of two (2) years. Reappointment is permitted. The Legal Representative may at the same time be a member but not the Chairman of the National Board.

(2) The Legal Representative shall report to the National Board. All transactions shall be documented and periodically reviewed by the National Board.

(3) Any transactions that result in liabilities of the National Chamber exceeding RMB 100,000 require the prior approval of the National Board.

(4) The Legal Representative shall keep the company seal at the registered office of the National Chamber at any time and may not hand it out to any other person without prior approval of the National Board.

## **ARTICLE 9 FINANCE**

(1) The National Chamber's funds and assets consist of:

(a) Membership contributions;

- (b) Reimbursements for costs incurred by the National Chamber when rendering services;
  - (c) Subsidies and other grants from third parties;
  - (d) Income from interest accrued on securities and other properties owned by the National Chamber;
  - (e) Other legal financial resources.
- (2) The National Board shall dispose of the National Chamber's financial resources in accordance with the budget approved by the National General Assembly. Where the National Chamber receives special purpose grants, such may only be used for the intended purposes.
- (3) No member of the National Chamber shall have any individual right regarding the National Chamber's assets and financial means.
- (4) If the National Chamber is dissolved, any assets remaining after settlement of liabilities and not dedicated to any special purposes shall, by decision of an Extraordinary National General Assembly, be transferred to an institution or a project promoting Sino-Swiss economic relations or serving humanitarian or educational goals.
- (5) The National Chamber may establish bank accounts.

## **ARTICLE 10 LIABILITIES**

Liabilities shall be met exclusively from the National Chamber's assets. No member of the National Board or the executive staff (including the Legal Representative) may be held personally liable for the National Chamber's liabilities.

## **ARTICLE 11 ACCOUNTING BOOKS**

- (1) The income or expenditure of the National Chamber and the activities relating to such income or expenditure, together with the assets and liabilities of the National Chamber shall be recorded in the accounting book. The accounting book shall be kept at the registered address of the National Chamber or at other place considered appropriate by the National Board.
- (2) The accounting books shall be open to members for inspection subject to reasonable limitations laid down by the National General Assembly with regard to the time or method of such inspection.

## **ARTICLE 12 AUDITOR**

The National Chamber's accounts must be audited every year by an Auditor, who shall not be a member of the National Board or a Regional Board. The Auditor is proposed by the National Board and elected by the National General Assembly for a period of one year. The Auditor shall inspect the annual financial statements, including cash flow statements and other documents. He has the right to require submission of financial statements and relevant documents, and to inspect the current balance situation. The result of the inspection shall be reported in written form to the National Board and submitted to the National General Assembly.

## **ARTICLE 13 ARBITRATION**

The National Board may appoint an Arbitration Committee to settle disputes among members of the National Chamber.

## **ARTICLE 14 AMENDMENTS TO THE ARTICLES AND BYLAWS OF THE NATIONAL CHAMBER**

(1) The National Articles may be amended by two-thirds ( $\frac{2}{3}$ ) majority of the members with voting rights present in person or by proxy at the National General Assembly on the proposal of the National Board or following a written motion by at least one tenth (1/10) of all members with voting rights of the National Chamber.

(2) The National Board may draft, amend or repeal the National Bylaws in accordance with the National Articles. The National Bylaws and any amendment thereto or repeal thereof shall only become effective upon approval by a simple majority of the members with voting rights present in person or by proxy at the National General Assembly.

(3) The members of the National Chamber shall be notified of any changes to the National Articles or the National Bylaws.

## **ARTICLE 15 DISSOLUTION OF THE NATIONAL CHAMBER**

(1) The National Chamber may only be dissolved by a decision of an Extraordinary National General Assembly exclusively convened for this purpose.

(2) The invitation to attend such an Extraordinary National General Assembly must (i) specifically indicate the purpose of the meeting being the decision on dissolution of the National Chamber, and (ii) be mailed at least six (6) weeks prior to the meeting. After dissolution, the assets and property will be handled in accordance with Article 9(4) of the National Articles.

## **ARTICLE 16 FINAL PROVISION**

(1) The National Articles are written in Chinese and English. In case of conflict, the Chinese version shall prevail.

(2) The National Articles are with the Ministry of Civil Affairs as [of a date that needs to be confirmed], per the approved resolution by the meeting of the National General Assembly held on March 27, 2015.

# SWISS CHINESE CHAMBER OF COMMERCE CHINA BYLAWS

("National Bylaws")

Last modified by resolution of the National General Assembly of March 27, 2015.

## ARTICLE 1 DEFINITIONS

For the purpose of these Bylaws and of any Regional Bylaws:

***The Swiss Chinese Chamber of Commerce (the "National Chamber")*** is the legally established chamber of commerce concerned with Sino Swiss economic and trade relations in the People's Republic of China ("China").

***The Articles of Association (the "National Articles")*** are the basic rules with regard to the founding and organization of the National Chamber as last approved on [date to be confirmed] by the Ministry of Civil Affairs. They apply to all members and organizations within the National Chamber.

***The National Bylaws*** are a set of practical regulations and guidelines written in order to clarify the National Articles where necessary and to ensure the smooth operation of the National Chamber. They apply to all members and organizations within the National Chamber.

***The Board of Directors of the National Chamber (the "National Board")*** is the executive Board of the National Chamber.

***The National General Assembly (the "NAGA")*** includes all members of the National Chamber and is the supreme body of the National Chamber.

***Regional Chambers*** are the regional organizations within the National Chamber.

***The Board of Directors of a Regional Chamber (the "Regional Board")*** is the executive Board of a Regional Chamber.

***Regional Bylaws*** are a set of practical regulations and guidelines based on the National Articles and the National Bylaws written to ensure the smooth operation of a Regional Chamber.

***The Regional General Assembly (the "RAGA")*** includes the members of a Regional Chamber and is the supreme body of such Regional Chamber.

## **ARTICLE 2 REGIONAL CHAMBERS**

**(1)** The National Chamber recognizes the diversity of business activities in China and serves its members locally through its Regional Chambers.

**(2)** Regional Chambers are established upon request by a regional group of members of the National Chamber to the National Board, proposal by the National Board and approval by the NAGA. For the time being, Regional Chambers exist in Beijing, Shanghai and Guangzhou.

**(3)** Each Regional Chamber may hire its own staff and shall be independent in the management of its employees. The National Board shall not interfere in the daily management of the Regional Chamber unless such interference is required to protect the interest of the National Chamber.

**(4)** Each Regional Chamber may adopt, alter, repeal Regional Bylaws, provided that they comply with the National Articles and the National Bylaws. The National Board shall confirm compliance of such Regional Bylaws or any amendments thereto with the National Articles and the National Bylaws. The Regional Bylaws and any amendment thereto shall only become effective upon approval by the NAGA by simple majority vote.

**(5)** Each Regional Chamber contributes an amount of money to cover the annual administrative expenses accrued by the National Chamber according to the regional budgets approved by the NAGA. Such financial contribution requires the approval of the respective Regional Board.

**(5)** Bookkeeping is carried out within and by the Regional Chambers. The Regional Chambers shall follow PRC accounting rules and regulations (Chinese GAP), the National Articles and the National Bylaws for the financial accounting of their activities.

For consolidation purposes, the Regional Chambers shall establish their financial statements according to the chart of accounts established by the National Board. The Treasurer of the National Chamber shall establish or amend the chart of accounts subject to prior consultation with the Treasurer of each Regional Chamber.

**(6)** Each Regional Chamber shall submit to the National Board the following documents at the latest 45 days prior to the date of the NAGA:

Report on activities conducted and attended by members of the Regional Chamber;  
explanation of accounts;  
Assets & Liabilities and Profit & Loss reports;  
Fixed Assets lists;

General Ledger;

Membership list, including information of whether membership fees are paid to ascertain voting rights;

One supporting document for every entry in the General Ledger;

Budget for the new business year.

### **ARTICLE 3 CO OPERATION WITH SWISS CHINESE CHAMBER OF COMMERCE ZURICH**

**(1)** The National Chamber recognizes the value and importance of close cooperation with the Swiss Chinese Chamber of Commerce, Zurich, and its regional organizations in Switzerland.

**(2)** Visiting members of the Swiss Chinese Chamber of Commerce, Zurich, or of its regional chapters, have the same rights as members described in Article 4 (6) of the National Bylaws, but do not have voting rights.

**(3)** Individual members of the Swiss Chinese Chamber of Commerce, Zurich, or of its regional chapters, taking residence in China and having paid their annual fees in Switzerland can enjoy membership status in a Regional Chamber, but do not have voting rights until the next RAGA. This privilege does not apply to Corporate Members.

### **ARTICLE 4 MEMBERSHIP**

**(1)** Applicants submit their application to the respective Regional Board.

**(2)** Candidates for National Honorary Membership shall not be required to make applications. Admissions to National Honorary Membership shall be proposed by the National Board upon recommendation by a Regional Board and approved by the NAGA.

**(3)** Each Regional Board shall, except with respect to National Honorary Membership, decide on the admissibility of an applicant for membership or for a change in classification of membership by simple majority.

**(4)** Members accepted by a Regional Board that do not qualify for Corporate Membership or Individual Membership shall be listed as “National Corporate Associates” or “National Individual Associates” without voting rights.

**(5)** An application may be refused without giving any reason. If an application has been refused, any member of the respective Chamber may file a motion to the Regional Board requesting for admitting the applicant at the next RAGA. Such resolution must be approved by two thirds ( $\frac{2}{3}$ ) of the members present in person or by proxy at the RAGA.

(6) Members have the right to attend all activities of any Regional Chamber at members' conditions.

(7) Members shall pay an annual membership fee to the respective Regional Chamber.

(8) The yearly amount of membership fees shall be approved by the RAGA upon proposal by the Regional Board and, following approval by the RAGA, confirmed by the NAGA.

(9) Updated member lists are filed with the Regional Board and the National Board.

## **ARTICLE 5 REGIONAL GENERAL ASSEMBLY**

(1) The RAGA is the supreme body of each Regional Chamber.

(2) Each Regional Chamber shall hold at least one RAGA per year.

## **ARTICLE 6 REGIONAL BOARD**

(1) Members of the Regional Board shall be elected by the RAGA.

(2) Eligible for election as a board member is only a person who is a member with voting rights of the respective Regional Chamber or a representative of such member with voting rights.

(3) The Regional Board constitutes itself. The President of the Regional Board shall be confirmed by the RAGA upon proposal by the Regional Board, and thereupon, confirmed by the NAGA.

(4) The term of office of a member of the Regional Board is one (1) year. Re-election of an ordinary member of the Regional Board is possible for maximum six (6) consecutive terms, i.e. totally six (6) consecutive years. Re-election of the President of the Regional Board is possible for maximum four (4) consecutive terms, i.e. totally four (4) consecutive years.

(5) In case of negligence of duty, violation of Chinese laws or regulations or any other behavior detrimental to the Regional Chamber and the Swiss Business Community in China, any Regional Board member may be removed from office by the Regional Board by a vote of at least three-quarters ( $\frac{3}{4}$ ) of all members of the Regional Board.

## **ARTICLE 7 NOMINATION TO THE NATIONAL BOARD**

(1) Each Regional Chamber shall nominate candidates for the National Board to the NAGA for election.



(2) The Regional Chambers in Beijing and Shanghai shall each be represented by three (3) members, the Regional Chamber in Guangzhou by one (1) member on the National Board.

(3) The Chairman of the National Board shall alternate between nominees of the different Regional Chambers every two years, unless a Regional Board whose turn it is forfeits its right to nominate its candidate and the Chairman is elected with a two thirds ( $\frac{2}{3}$ ) majority by the NAGA.

(4) The President of a Regional Board shall not be nominated as Chairman of the National Board unless such nomination is confirmed by the NAGA by a vote of at least two thirds ( $\frac{2}{3}$ ) of the members present by person or by proxy at the NAGA.

## **ARTICLE 8 NATIONAL GENERAL ASSEMBLY**

(1) The ordinary NAGA meeting shall in principle take place each time under the auspices of a different Regional Chamber, on a rotating basis.

(2) A member shall have voting rights at a NAGA, under the conditions that:

- (a) either (i) the member personally attends the NAGA meeting, or (ii) appoints a proxy by means of a written and signed original authorization letter to be presented by the proxy at the NAGA meeting. Such proxy letter shall specify the nature of the meeting and its date, the member to be represented and the member acting as proxy; and
- (b) the member has been confirmed by the National Board based on the list provided by the Regional Boards; and
- (c) the member has paid all his dues in full before the NAGA meeting for the year the NAGA meeting is closing.

The National Board shall establish the representation of members at the NAGA meeting and to announce each representation before the first voting.

## **ARTICLE 9 AWARD OF CONTRACTS**

(1) An open bidding process, including at least all members of the respective Chamber, shall be conducted prior to any award of contracts beyond the amount of RMB 100,000. The National Board shall approve any such award of contracts.

(2) Regional and National Board members or their employers shall be awarded such contracts only if they are proven to be more competitive than other bidders and after other bidders have been informed of the bid by the Board member or their employers and had the opportunity to counteroffer.

## **ARTICLE 10 FINAL PROVISIONS**

**(1)** The National Bylaws and any amendment thereto shall only become effective upon approval by a simple majority of the members present in person or by proxy at the NAGA.

**(2)** The National Bylaws shall come into effect upon (i) approval by the NAGA held on 27 March 2015, and (ii) approval of the National Articles by the Ministry of Civil Affairs on [date to be confirmed].

## APPENDIX F

### **SWISSCHAM BEIJING REGIONAL BYLAWS**

Swiss Chinese Chamber of Commerce Beijing

("BEIJING BYLAWS")

Last modified by resolution of the Annual General Assembly of 27 March 2009.

Registered office changed in 2015.

The Swiss Chinese Chamber of Commerce ("SwissCham" or "the Chamber") is a foreign chamber of commerce established in accordance with the relevant laws and regulations of the People's Republic of China.

The Chamber has its registered office at Room 611, Xinyuanli West 19, Chaoyang District, Beijing 100027, China.

In accordance with Article III, Section 2 of its Bylaws, the Chamber has decided to establish a Regional Organization and issues the following Regional Bylaws<sup>8</sup>

#### **ARTICLE 1 - STATUS, NAME AND OFFICE<sup>9</sup>**

SwissCham Beijing is a Regional Organization of the Chamber.

The Regional Organization shall be named "Swiss Chinese Chamber of Commerce Beijing" or "SwissCham Beijing".

SwissCham Beijing shall have its offices at the Chamber.

#### **ARTICLE 2 - PURPOSE**

SwissCham shall promote the Chamber's purpose in the Beijing region.

## BEIJING BYLAWS

### ARTICLE 3 - TERRITORY

SwissCham Beijing covers the region of Northern China meaning the territory north of the Yangtse river.

### ARTICLE 4 - MEMBERSHIP<sup>10</sup>

Those Members of the Chamber shall also be Members of SwissCham Beijing who:

(a) are incorporated or have residence in the territory defined in Article 3;

(b) submit their membership application for the Chamber through the offices of SwissCham Beijing.

The membership categories are defined at Art. 3, Sec. A of the National Articles of Association and Art. V, Sec. 2(2) of the National Bylaws.

"As stated by Art. V, Sec. 2 and 3 of the National Bylaws, the BOD decides on the admissibility of an applicant or on a change in classification of membership by simple majority.

"In principle, applicants are admitted as Corporate Member.

"Additional regional member categories include:

"(a) Corporate Membership: Commercial establishments such as representative offices, joint ventures, branches or subsidiaries, set up in China in accordance with Chinese law by companies, institutes or associations not located in Switzerland; Additional employees of Corporate Members are eligible as Corporate Affiliates;

"(b) Individual Membership: All non-Swiss citizens who are not employed by a commercial establishment such as representative offices, joint ventures, branches or subsidiaries, set up in China in accordance with Chinese law by companies, institutes or associations located in Switzerland;

"(c) Associate Membership: Members accepted by the Regional BOD that do not qualify for national membership. Namely, students and young professionals are eligible for Associate Membership. So are business associations as per Art. IV, Sec. 2 of the National Bylaws.

## APPENDIX F

"(d) Honorary Membership: Personalities who have made great contribution to or earned lasting merits for either the trade relations between Switzerland and China or the Regional Organization.

"Additional regional members do not enjoy voting rights.

### **ARTICLE 5 - MEMBERSHIP FEES**

The Members shall pay a membership fee that will be submitted by the Regional Board for approval by the Regional General Assembly Meeting. The membership dues shall be paid within one month after receipt of the notification.

In addition to Article 4 Section C of the Articles, Membership terminates in case of non-payment of the membership fees within 6 months after the annual GA meeting. The treasurer of the Beijing Chapter shall send out payment reminders at least twice and report the status of unpaid membership fees at every meeting of the board.

### **ARTICLE 6 - REGIONAL GENERAL ASSEMBLY**

The Regional General Assembly of the Members shall be the supreme BOD of SwissCham Beijing. Its decisions shall be subject only to the decisions, rules and regulations of the Chamber.

The Regional General Assembly shall function according to the rules outlined in Article 5<sup>11</sup> of the Articles of Association of the Chamber.

(a) The Swiss Embassy Beijing is a standing Honorary Member of the Beijing Chamber.

(b) Invitation to the annual Beijing GA will be sent 30 days in advance and include the following documents:

- (i) Agenda
- (ii) Activity report of the Board
- (iii) Accounts for the past period and auditors' identification
- (iv) Program and budget for the next period

- (v) Candidacies call to the Board
- (vi) Amendment proposals for the Beijing bylaws, when relevant
- (c) Quorum for the Beijing GA is 50% of membership with voting right.
- (d) A member has voting rights when he has paid his membership fee for the past period and all other dues.
- (e) Representative functions of the Board (President, National Representatives) are elected by the GA, others are decided within the Board
- (f) Board members are elected by secret ballot. A member is elected to the Board only if a simple majority of the represented members at the GA have voted for them.
- (g) A secret ballot will be conducted:
  - (i) If the Chair of the GA so requests or
  - (ii) If 2 members of the GA so request.

### **ARTICLE 7 - REGIONAL BOARD OF DIRECTORS & EXECUTIVE STAFF**

The Regional Board of Directors is in charge of management and representation of SwissCham Beijing.

It shall be convened and function according to the rules outlined in Article 6<sup>12</sup> of the Articles of Association of the Chamber.

It may appoint a manager for taking care of daily matters, as well as other staff. Manager and other staff need not be Members of the Chamber.

- (a) Board Members are elected for one year.
- (b) Board is constituted of a maximum of 11<sup>13</sup> Members, which does not include honorary Board members, as relevant.
- (c) Typically, Board Members are expected to attend 2/3rd of scheduled Board Meetings. Attendance of Board Members to past year Board Meetings will be announced within the election process. The Board Members may not stand if

they did not attend 2/3rd of scheduled Board Meetings.<sup>14</sup>

(d) Board membership is revoked in case a Board Member of corporate category changes company.

(e) Before annual elections to the Board or, in case of a vacancy, before selecting a temporary Board member, the Board shall make an open call for candidacy to all the membership.

(f) An open bidding process, including all members shall be followed for the awarding of contracts approved by the Board.

(g) Board members shall not be included in the bidding of SwissCham Beijing projects and shall not take such contracts.

(h) Responsibilities of the Executive Director (ExD) include:

(i) Daily Beijing Chamber activities

(ii) Events

(iii) Sales & marketing

(iv) New members acquisition

(v) Services offered by the Beijing Chamber

(vi) Profit & loss accountability

(j) The Board will set targets expenses level, manage and review performance of the ExD on a bi-annual basis.

## ARTICLE 8 - FINANCE

The Beijing Chapter provides the appropriate bookkeeping and accounting measures for its finances and reports to the National Board.

With regard to financial matters the rules outlined in Articles 8 and 11 of the Articles of Association of the Chamber also apply to SwissCham Beijing.

## BEIJING BYLAWS

### ARTICLE 9 - AUDITOR

An Auditor proposed by the Regional Board of Directors and elected at the Regional General Meeting for a period of one year must audit SwissCham's accounts once a year.

The Auditor shall inspect the annual financial statements, including cash flow statements and other documents. He has the right to require submission of financial statements and relevant documents, and to inspect the current balance situation. The result of the inspection shall be reported in written forms to the Regional Board and submitted to the Regional General Meeting.

After approval by the Regional General Meeting, the Auditor's report on the financial statements of SwissCham Beijing shall be forwarded to the Board of Directors of the Chamber 14 days before the date of the General Assembly Meeting of the Chamber.

### ARTICLE 10 - REPORTING TO THE CHAMBER

The President of the Beijing Chapter shall submit an Annual Report to the Board of Director of the Chamber 14 days before the date of the General Assembly Meeting of the Chamber including:

- (a) Activities conducted and attended by members of the Beijing Chapter
- (b) Budget for the new calendar year
- (c) Updated register of Members

### ARTICLE 11 - FINAL PROVISIONS

These Bylaws are effective as of the General Meeting of the Chamber of 18 April 2001.

They have last been amended at the Meeting of the Chamber of 27 March 2009.

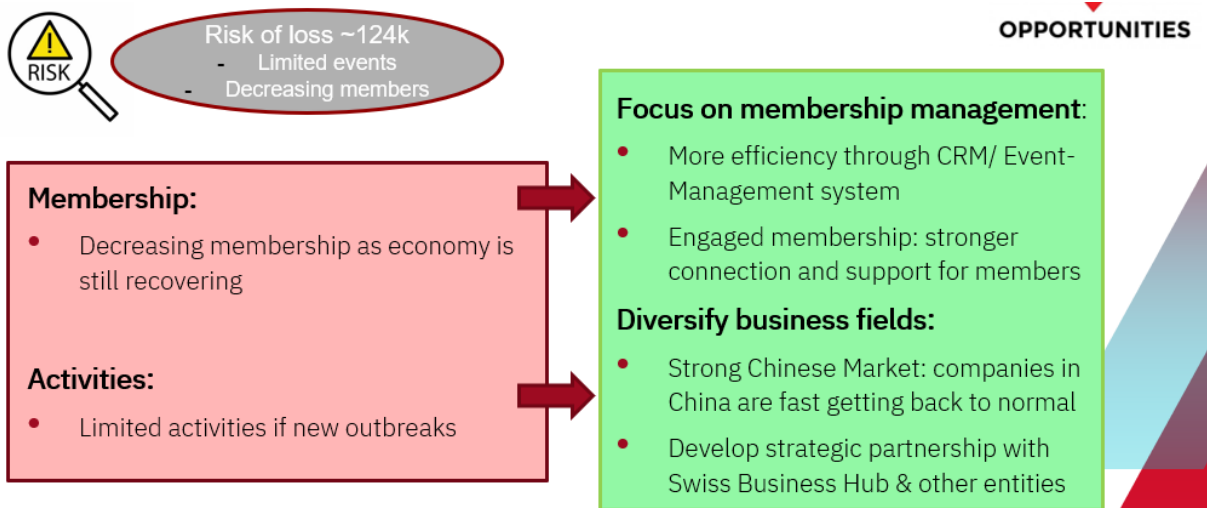


- In fiscal year 2020, SwissCham Beijing realized net revenues of **CNY1’337k** and net expenses amounted to **CNY1’256k**, resulting in a total net profit of **CNY81k**.
- In 2020, SwissCham Beijing finalized a net profit of **CNY81K**, which was the net result of total net revenue of **CNY1,337K** and total cost of **CNY1,256K**.
- This compares to budgeted profit of CNY1K, as a result of budgeted net revenue of **CNY1,440K** and budgeted cost of **CNY1,439K**.
- The great success of the SSEF 2020 financially protected the COVID-19 impact to SwissCham.
- 2020 total net revenue of **CNY1,337K** was mainly contributed by:
  - Membership fees: **CNY560K**
  - Events: **CNY623K**
  - Products: **CNY154K**
- Membership fees, Sino Swiss Economic Forum and yearly sponsors mainly contributed to the net revenue in 2020.
- 2020 total actual cost of **CNY1,256K** were mainly composed of:
  - Staff Cost: CNY921K, or 73%;
  - G&A Cost: CNY335K, or 27%.
- The above actual cost total was quite under the budgeted cost of **CNY1,439K**.
- During 2020, SwissCham Beijing had 3 full time staff, 3 paid interns on average. Since June 2020, changed into 2 full time staff, 2 paid interns.

- In 2020, the average cash position amounted to **CNY1'148K**.
- The Sino Swiss Economic Forum, membership payments and yearly sponsors increased the cash position in 2020.
- The yearly sponsorship payments increased cash position in the beginning and end of the year, while membership payment contribute the middle. The two cash position valleys mainly due to office rental.

**Daniel Aellen presents the 2021 Budget:**

- 2021 budgeted profit is **CNY1K**, based on total net revenue of **CNY1,305K** and total cost of **1,304K**.
- The revenue decreases of practical marketing expectation in 2021.
- On the cost side we will have fully launched the new event bank system this year.
- After COVID-19: Challenge to manage expectations and achieve targets
  - Big challenges as China remains de facto cut-off from the rest of the world for the foreseeable future
  - Back to a normal situation partially impacted by the COVID19 recovery
  - Recovering economy vs. uncertainties related to event activities and membership renewal
- We have about RMB 1,000k in SwissCham account by the end of March 2021, which makes us able to face the worst case, but we still need to work hard to avoid the worst case.



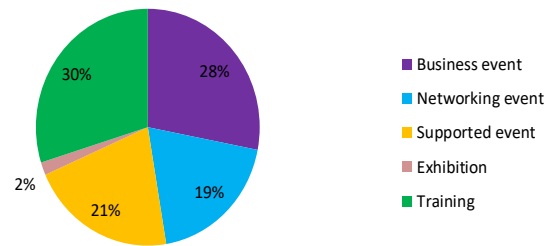
